Criteria for Submissions

A nominee must be a VOLUNTEER Youth Sports Coach that exemplifies character, passion, and drive to further their athlete's success. Your letter of recognition (three to five paragraphs) should include the nominee's name, age, and address, as well as your relationship with the coach. In the nomination essay, tell us their story, including what makes them an excellent coach, citing examples of the challenges he/she faces, their character, their service to others and their outstanding contributions to the sports program.

1. How to enter: Accepted nominations begin at 12:01 a.m. Mountain Standard time (MST) on May 4, 2017, and ends at 11:59 p.m. MST on June 23, 2017. To enter, visit BlackHillsParent.com and upload your story. Limit one entry per person, and entries exceeding 600 words may not be considered. BHParent is not responsible for lost, late, illegible or incomplete entries or entries not received for any reason. Entries become sole property of BHParent, and none will be acknowledged or returned. By entering, Entrant warrants that his or her entry (1) is original and does not infringe the intellectual-property rights of any third party and (2) has not been posted anywhere else.
2. Judging: BHParent editors will select honorees based on the emotional resonance and perceived reader interest of each coach's story and whether the entry adheres to the criteria: illustrating the challenges the nominee faces as well as the qualities of character, service to others, and contribution to the youth sports program. BHParent editors will select the honoree entries after June 23, who will be announced in the fall issue of BHParent magazine. Incomplete and/or inaccurate entries and entries not complying with all rules are subject to disqualification. Decisions of judges are final and binding. Honorees and their nominators will be notified by telephone and/or e-mail after June 23, 2017. The selected stories will also be posted on BlackHillsParent.com on/or around August 2017.
3. Eligibility: Open to legal residents of the Black Hills communities of South Dakota, age 18 or older at time of entry ("Entrant(s)"). Void where prohibited by law. Employees of BHParent are not eligible.
4. Recognition description: The selected honorees will be featured in the fall issue of BHParent magazine, and each will receive a commemorative gift on behalf of the featured sponsors and BHParent. The gift is awarded without warranty, express or implied, of any kind. The gift is not transferable. BlackHillsParent.com

reserves the right to edit or remove any blog content submitted by any Entrant, including the honoree, at any time for any reason.

5. Conditions of participation: Nothing in these official nomination rules shall obligate BHParent to publish or otherwise use any entry submitted in connection with this submission period. By entering, Entrant represents that any post, etc., and other materials submitted as part of Entrant's contest entry are original and will not constitute defamation or an invasion of privacy or otherwise infringe upon the rights of any third party, and that the Entrant owns or has the rights to convey any and all right and title in such post.
